# PR Report 3.13.2022

- Schedules have been updated on the website and BMLT. There are new schedules available. PLEASE spread the word that ALL OLD SCHEDULES need to be replaced with the updated ones. The old schedules have the help-line number that is no longer in service. The date on the schedule must be on or after 3/13/2022.
- We have reached out to local advertising agencies regarding billboards. Currently, we several different options. LAMAR has a preemptable digital program. This program allows us to purchase an unsold spot for a digital poster at a discounted non-profit rate of \$600.00 per month. Once that spot is sold to a full price paying customer, the digital poster will be bumped to another location in Columbia. That would allow the message to be seen all over the Columbia area, instead of just one location. GRACE OUTDOORS has several different locations and rates available for different size billboards. Initial production costs range from \$700.00 to \$1,200.00. That includes the first month as well. After that, the rates range from \$300.00 to \$900.00 per month depending on the location. COMET has bus stop ads available for \$450.00 per month. If purchased for the entire year, it is \$400.00 per month. I have attached a copy of the pricing and programs to this report, and will pass them around. Please discuss these options with your homegroup, and let us know next month.


