REPORTS:

- Steering Committee:
 - Chair Patrick P: Thanked those involved in the Area Inventory, stated we have started reviewing the audio recording of the meeting and are working on a complete transcription and a report that will address the concerns presented; anticipates having this ready by the January ASC meeting. Thanked the Freedom Group for hosting today and told Sumter and Orangeburg we await their bids to host. Expressed that the area's bank account has unfortunately been subject to a fraudulent withdrawal; the area Treasurer identified the fraud and initiated a claim within 24 hours of the transaction, and details will be included in his report. Assured that all proper protocols have been followed in a timely manner. Noted that he, the Treasurer, and the Policy & Procedure chair met with the acting manager at Wells Fargo on Saturday at 9AM after waiting the requested 10 business days for the fraud claim to process; he and the P&P chair will return on Monday at 9AM to follow-up in efforts to secure the return of the unauthorized withdrawal. Stated that if able, we will press charges without hesitation against the party responsible for "absconding with our funds." Reminded all GSRs to provide a working phone number to the Secretary to allow communication of any sudden changes; if privacy is preferred, phone numbers can be kept out of the area minutes. Stated that he obtained the Zoom meeting information for the GCANA ASC meeting, which began at 2PM this

afternoon, and had been planning to attend to seek clarity on how we are facilitating shared H&I services, as well as how we are funding the literature commitment. Expressed continuing encouragement for home groups and members to make donations to CCANA due to our financial deficit, further exacerbated by the recent fraud; donations will help us better serve the needs of the area as a whole and the suffering addict. Shared that he looks forward to seeing members at NANA's upcoming Holiday Party on Wednesday December 11th starting at 7PM. (Full Report Attached)

- Treasurer Jay N: Total revenue for the period was \$-1,046 due to two apparently unauthorized or • fraudulent ACH transactions that posted on 11/19/24 and 11/21/24. The recipient of the funds shows up as business-to-business, ACH Bank of America, QRMT payments 241116 and 241119, GRANITEHOS. The 11/19/24 transaction was for \$750 and the 11/21/24 transaction was for \$400. Wells Fargo was contacted on 11/22/24. The fraud investigator placed a Stop Payment on this recipient and disputed the transactions. Bank policy requires 10 business days for investigation, prolonged by Thanksgiving. Wells Fargo claimed that the dispute was too late, even though one of the transactions took place one day before the dispute; we are supposed to have 60 days. Wells Fargo recommended we reach out to the merchant, although the original fraud claim investigator was unable to provide the merchant's identity. Bank of America will not provide information on this merchant without a subpoena. Treasurer stated after contacting Wells Fargo several more times, he finally got in contact with a fraud investigator who informed that allegedly, funds were received by Granite Hospitality in Scottsdale, Arizona. Treasurer contacted Granite Hospitality, who claimed that they do not have accounts with Bank of America; they demonstrated confusion as they own hotels and do not accept ACH payment for services. Treasurer, Patrick, and Nick went to local Wells Fargo branch, where the branch manager on duty said the fraud department should not have shut down the claim so quickly (with apparently little to no investigation). Manager was unable to contact the fraud department as it was Saturday. Treasurer, Patrick, and Nick set an appointment with her for Monday [12/9/24]. In the meantime, a police report will be filed. Treasurer, Patrick, and Nick hope to resolve this matter quickly. No other unauthorized transactions since 11/21/24. Unauthorized charges are currently listed as Miscellaneous Expenses. Treasurer appreciates our patience with this matter. Total donations for the period were \$104.00 including \$25 donation from Rainbow Group and \$79 from Area Inventory Chili Cookoff. Treasurer made sure no more money was coming out of the account before depositing donations. (Full Report Attached)

- <u>Secretary Brittany G</u>: Absent with report. November 2024 minutes were emailed on November 19, 2024. (Full Report Attached)
- <u>Alt Secretary Emily E</u>: Requested all GSRs and subcommittee chairs confirm their contact information and submit any changes. Reminded everyone to submit new motions before the break and please submit any reports for the minutes before leaving today. Reminded GSRs if interested in hosting future area meetings, to confirm with appropriate channels ahead of time. (Full Report Attached)

 - <u>Hope Hole Stephanie R</u>: Brian F. will be celebrating 26 years on 12/28/24 at 9pm, Clif L. will be speaking.
 - <u>There is a Solution Amanda M</u>: Chris P. will be celebrating 2 years on 12/17/24 at 7:30pm, potluck dinner at 7pm. Meeting format is F*ck-It Bucket.
- Subcommittees:
 - <u>H&I Vaughn J:</u> Absent with report (Full Report Attached).
 - <u>P&P Nick A</u>: Stated that the area inventory went well, and he looks forward to the steering committee's response to the feedback received. Requested to add 2 items to today's agenda as area committee issues: 1) transparency in the ASC—ask any questions you might have, there should not be any secrets; and 2) sexist and/or homophobic comments in subcommittee meetings (as referenced at the area inventory)—would like to gather information and have discussion about this concern. Reminded that nominations remain open for Alt Treasurer and Literature Review, nominations for RCM and RUTS chairperson will be closed today and sent back to home groups. Informed that after last month's area meeting, the Alt RCM and Activities subcommittee chairperson were both considered to have voluntarily resigned because they were absent from 2 consecutive ASC meetings without report. Nominations for Alt RCM and Activities will open today in new business. Emphasized financial transparency and responsibility, stated we still have a budget of \$7,650 with donations not covering half of our budgeted expenses. Stated as per policy, we will continue to vote on all financial transactions, and we will have a written motion for every check written from the area's bank account. (Full Report Attached)
 - <u>PR Chris F</u>: Absent with report. PR has been working with web committee to get the BREAD plugin active on our website; this has streamlined the process of keeping schedules up-to-date. PR plans to order business cards with a QR code that brings up the schedule, and these will be distributed to local police, EMS, businesses/organizations to help carry the message. Next PR meeting will be 12/29/24 at 1pm where Naturally High meets [5220 Clemson Ave.]. (Full Report Attached)
 - <u>Web Heather F</u>: Informed that a few meetings and updates were added to the schedule: please bring new schedules to home groups, and update or throw away old schedules. BREAD plugin has been implemented which makes schedule changes much easier. Requested that if anyone sees an error on the schedule or wants to add an event to the website's calendar, please contact Heather F or Chris F. Next Web meeting will be 12/15/24 at 5pm at Starbucks 2408 Augusta Rd. (Full Report Attached)
 - <u>Welcome Home Rick M</u>: Absent with report. First Welcome Home XXVIII meeting was held on 11/23/24. All positions are still open; committee in need of people willing to serve. New flyer has been posted for

Logo/Theme contest and the next several committee meetings every 2 weeks for now at 1600 12th St. in Cayce on Saturdays at 5pm. (Full Report Attached)

GROUP CONCERNS (SHARING SESSION):

- Group Problems
 - Stephanie R Hope Hole: Concerned about lengths of the chair reports; home group feels the chair reports contain only a few sentences of relevant information and lots of "fluff." Also concerned about the group conscience for the policy & procedure subcommittee: is there a group conscience for writing motions etc. or is the chairperson just doing it himself? Nick stated that he has discussed with people at the P&P meeting at times, and the ideas for motions have come from various situations. Nick invited everyone to attend P&P subcommittee meetings at 2pm before ASC or contact him anytime to discuss area policy. Patrick noted that steering committee is trying to get our policy to line up with what we are actually doing, so several recent policy changes have been made simply to reflect what we do. Stephanie asked whether people were contacted before being removed from their service positions; Patrick stated they were all contacted. Garret sought and received clarification that regardless of where an idea comes from, any policy changes must go through the group.
 - Amanda M There is a Solution: Expressed personal concerns about the first Welcome Home committee meeting and about the way the Welcome Home chair and Policy & Procedures chair conducted themselves before & during the meeting. Stated she attended the meeting feeling excited to be of service. Stated that before the meeting started, a member said, "I don't even bother learning anybody's name unless they have more than five years" and another member agreed with him. Stated that she told them this comment was offensive, and the newcomer is the most important person in a meeting, but the two members "just laughed." Shared further details about how she and others were made to feel dismissed and unwelcome at the meeting. Clarified that she is not upset about clean time requirements for service positions, but she is upset and hurt because she was made to feel like her desire to be of service was unwanted. Acknowledged that newcomers remind us of where we have come from and that we must promote unity. Amanda P apologized on behalf of the Welcome Home committee, pointed out that it is not unusual for clean time requirements to be waived, and stated that she will be at the next meeting as a voice for the newcomer. Policy & Procedures chair apologized to Amanda M, stating he did not intend to offend her. The Welcome Home chair was absent with report, therefore unable to respond at this time. Mike V also apologized, and he & several members encouraged Amanda M to remain in the spirit of service & unity and not let this instance stop her from being of service. (Amanda's Full Statement Attached)
 - George: requested assistance with the tax ID number to open a bank account. Nick informed that the form for employee identification number (to get a tax ID for a group) is IRS form SS4.
- Groups Issues (Area Committee Issues)
 - Nick A: asked for feedback or questions regarding transparency in the ASC. Amanda P (Ladies Night) brought this up at the area inventory, specifically transparency from the "executive level of area." Amanda P clarified that the concern was about steering committee members joining subcommittees—are they joining in a capacity to just be a part of that subcommittee, or are they

there in an official capacity? Nick stated that he attends genuinely to be of service, but he will freely share his experience if other members ask for it (not keeping secrets). Patrick acknowledges that the ASC Vice Chair is supposed to attend all subcommittee meetings, but he does not, so "Nick kind of does it for him."

Nick A: asked for information sexist or homophobic comments in subcommittee meetings, which was brought up at the area inventory. Amanda M provided the example of women asking questions and being dismissed by older men (e.g. "listen here, young lady" at the Welcome Home meeting); when women are talked over, ignored, dismissed, put in a lesser category, these are sexist acts. Heather asked to table the discussion. Stephanie R added there have been many times when she has been dismissed, spoken over, etc. while involved in service, and even if it was not meant to be sexist, she feels it is sexist. Several members redirected the conversation to seeking solutions rather than focusing on individual behaviors, reminding members to place principles before personalities and respect our brothers and sisters in recovery.

I stand corrected and am certainly not beyond reproach. That said, I might argue that with the attached chili cook-off and the funds raised for the area it was the best Area Inventory in 25 years! In my humble opinion, our Welcome Home Convention Chair, Rick M, made the best chili, though I personally enjoyed them all—until I remembered that I'm nearly 50, and that much chili has consequences.

We have started to review the audio recording of the meeting and are working to put together a complete transcription, along with a report that will address the concerns presented. I anticipate having this ready by the January ASC.

I would also like to thank the Freedom Group for hosting the area meeting here in the picturesque city of Camden. Sumter and Orangeburg, we are waiting for your bids to host the area meeting. Maybe today will be the day! We are willing and ready as a steering committee, for either city to roll out the red carpet and have us in your city for an area business meeting—perhaps when the weather warms up.

Since the last area meeting, we have unfortunately been subject to a fraudulent withdrawal from the area bank account. The area treasurer identified the fraud and initiated a claim within 24 hours of the transaction posting against our account. The details will be included in his report, but I want to assure every home group and area member that we have been following all proper protocols, in a timely manner, to recover our lost funds.

The Treasurer, the Policy and Procedure Chair, and I met with the acting manager at Wells Fargo on Saturday morning at 9 AM, after waiting the requested ten business days for the fraud claim to process. I will be returning with the Policy and Procedure Chair on Monday morning at 9 AM for a follow-up meeting with her to further our efforts to secure the return of the unauthorized withdrawal. If we are able to press charges against the party responsible for absconding with our funds, we will do so without hesitation.

There continues to be a standing request for all GSRs to provide a working telephone number to the Secretary. Having direct contact information would greatly assist in communicating any sudden changes that may arise between area meetings. If you prefer to keep your number private and out of the area minutes, accommodations can be made.

Central Carolina Area or Narcotics Anonymous Area Service Committee Meeting Chair Report December 8, 2024

In my ongoing dialogue with the GCANA Treasurer, I was able to secure the Zoom meeting address and password for the GCANA ASC meeting, which began at 2 PM this afternoon. As of this writing, we were planning to attend the meeting to seek clarity on how we are facilitating shared H&I services, as well as how we are funding the literature commitment. There has been a lack of clarity in this area, and it must be resolved. No one serving in an honest capacity should be left "holding the bag" while trying to carry the message to addicts behind the walls or in facilities.

Due to the financial deficit in our area, which has been further exacerbated by the recent financial fraud, we continue to encourage local home groups and NA members to make donations to CCANA. These funds will help us better serve the needs of the area as a whole, as well as those of the suffering addict.

I look forward to seeing members at the NANA Holiday Party next Wednesday, starting at 7 PM. It's always a wonderful opportunity to connect with people from all over the area, and beyond, for food, fun, and fellowship.

Treasurer Report December 8, 2024

Total Revenue for the period was -\$1,046.00 for the month due to what appears to be 2 unauthorized and/or fraudulent ACH transactions on the account that posted on 11/19 and 11/21/2024. The recipient of the funds shows up as BUSINESS TO BUSINESS ACH BANK OF AMERICA QRMT Pymnt 24116 and Pymnt 24119 for \$750(11/19) and \$400(11/21) respectively. Upon learning of these transactions, several steering committee members were contacted and Wells Fargo was contacted on Friday, 11/22/2024. The fraud investigator placed a Stop Payment(see document) on this recipient and disputed the transactions. Bank policy requires 10 business days to await the findings of an investigation, which was prolonged by the Thanksgiving holiday. Wells Fargo claimed that the dispute was too late despite the fact that one of the transactions took place 1 day before the dispute. We are supposed to have 60 days. They recommended that we reach out to the merchant despite the initial fraud claim investigator not being able to provide us with who they actually were. Bank of America won't give us any information on who it is without a subpoena. I contacted Wells Fargo multiple more times and finally got in contact with a veteran fraud investigator who was able to tell me that it is showing as Granite Hospitality in Scottsdale, AZ who allegedly received the funds. After multiple attempts, I was able to get through to Granite Hospitality, and they claim they do not even have accounts with Bank of America and demonstrated confusion as they own hotels and don't accept ACH payment for their services. Patrick, Nick, and I went into our local Wells Fargo branch, and the branch manager on duty said the fraud department should not have shut our claim down so quickly(and it appeared little to no investigation had been done). She tried to contact them but was unable to due to it being Saturday. We have an appointment with her on Monday. In the meantime, we are filing a police report and hoping to resolve this matter quickly. No other unauthorized transactions have occurred since 11/21/2024. The unauthorized charges are currently listed as Miscellaneous Expenses until the matter is reconciled. Thank you for your patience with this matter, as it has been somewhat stressful. Total Donations for the period were \$104.00. This includes a \$25 donation from the Rainbow Group and \$79 from the Area Inventory Chili Cookoff listed as a Unity Events Donation. The current QuickBooks balance is \$5,432.49 which matches Wells fargo bank balance as of 12/07/2024. Thank you for allowing me to serve as Treasurer. JAY N.

ATM Cash Deposit Security Limitations

Effective November 6, 2024, the section of the Deposit Account Agreement titled "Depositing Funds," subsection titled "Our right to decline deposits," is deleted and replaced with the following:

Our right to decline deposits

We may decline all or part of a deposit, including cash, for any reason. This could happen, for example, if a payee isn't a co-owner, authorized signer, or authorized representative on your account, we can't verify an endorsement, the check was issued from a credit account, the dollar amount of the deposit, the check looks suspicious, or it's a non-U.S. item. If we decline a deposit that you mailed to us, we may return it to you at your cost (including charging you for postage and handling to return foreign currency coin or paper), or retain any invalid checks or other documents included in the deposit without crediting your account, at our discretion. There are limits on the total dollar amount of checks that can be deposited at Wells Fargo ATMs per transaction. We may decline ATM check deposits that exceed \$1 million. For security reasons there may also be limits on the dollar amount or frequency of cash deposits you can make at Wells Fargo ATMs.

If we cannot verify an endorsement, we can also decline to pay, cash, or send the item for collection. We can require that all endorsers be present and that you deposit the item instead of cashing it.

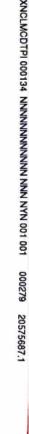

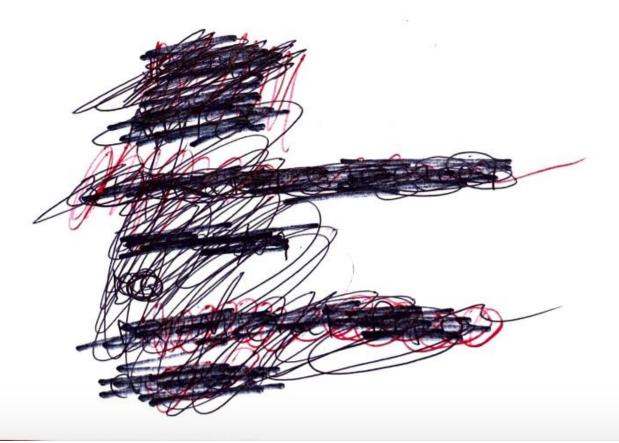

Hi Amanda Addict

My concerns are about how the first Welcome Home Committee meeting was conducted and how the chairperson for Welcome Home and the AREA policy and procedures chair conducted themselves before and during that first meeting. I went to this meeting happy and excited because I wanted to be of service to a convention that I have seen bring not only joy and unity but knowledge to myself and others. Before the meeting even started I made the comment to another addict that I didn't think many people would be there that day due to a lot of people from NA would be at a wedding of two of our fellow addicts. When asked who was getting married and I said who, immediately said "I don't know who they are, they must be newcomers". When I stated no they have been in NA for 4 maybe 5 years.

then made the statement "Oh yea they have less than 5 years, I don't even bother learning anyone's name unless they have more than 5 years" and agreed with him. When I stated that that comment was offensive and went against what NA was about. Stating that the new Comer is the most important person in a meeting they both, **Constant** just laughed at me. After the meeting started, and proceeded to tell those few of us there that there were time requirements for being on the committee. When asked if a person didn't meet the time requirements would we still be able to help their answers were very vague and made myself and a few others feel very unwanted. When myself and another addict were voicing concerns about who asked to be treasurer our questions were dismissed and laughed at. I had had

enough, after being told multiple times by that he had 32 years Clean, that he sat on the first Welcome Home committee 30 years ago and he knew how things should be I had to voice my concerns with how I felt that our help and opinions were being dismissed. When I began to speak on how I felt, interrupted me multiple times. When I asked him to please let me speak he then raised his voice to me stating "Listen here young lady" like I was a child being scolded. I had enough and walked out of the meeting. I understand that there are time requirements for certain positions and I am not upset that due to not meeting those requirements I couldn't chair any part of the committee. I am upset and hurt at how I was made to feel that my desire to be of service was unwanted and dismissed because in and seves I was unworthy due to not
